### Safe Handling of Asbestos-Cement Pipe in the Water/Wastewater Industry

“The mere mention of asbestos can send fear through a population. Many of these fears stem from a misconception that anything made of asbestos is hazardous.” *Eric Fullan*

Discover a new, less cumbersome way to comply with the state’s asbestos standard. This day-long course includes an overview of a Letter of Agreement with Oregon OSHA and PNWS AWWA that prescribes accepted wet methods. Join us as we review OSHA and DEQ requirements as well as hazards associated with Asbestos, A-C pipe work procedures, the right tools and equipment, proper PPEs, and decontamination protocols. We’ll also review proper excavation measures and confined-space safety practices.

The course is approved for CEUs for both Water and Wastewater by the OESAC Committee. Participants will receive handouts and CEU certificates.
